Sites covered by this statement

This online Privacy statement covers the collection and use of data on the Abbrazzio website.

Information Abbrazzio collects

Abbrazzio collects two kinds of information; Personal Identifiable Information (Information that let us know the specifics of who you are) and Non-Personal Identifiable Information (information that does not by itself identify a specific individual).

Abbrazzio collects Personal Identifiable Information (PII) when you use the website. It may e.g. include your name, home address, phone number, e-mail address, employer, and job title. Abbrazzio request PII when you ask us to send you product information directly or to other people; in that case Abbrazzio will collect information you submit about they recipient. It will be clear when you are on a part of the website that requires PII because Abbrazzio will ask you for it. And you will have the choice about how Abbrazzio uses that information.

The Non-Personal Identifiable Information (NPII) Abbrazzio collects when you visit the website may include the Uniform Resource Locator (URL) of the website that you came from before visiting the Abbrazzio website, your Internet Protocol (IP) address, and any search terms entered on the website.

Why Abbrazzio collects your information

The purpose of collecting information is to provide you, the customer, superior service and a smooth, efficient, and personalized experience while using the website. PII we use to provide the requested information. NPII is used to analyze customer behavior to help Abbrazzio understand how visitors use the website, to make the site easier to use and to customize our customer approach.

How Abbrazzio uses your information

Abbrazzio collects certain NPII when you visit the website or click on banner ads for Abbrazzio products and services. Abbrazzio collect this information to help run the website more efficiently, to gather demographic information, to monitor the level of activity on the website, and to evaluate effectiveness.

Abbrazzio collects PII when you register your Abbrazzio products online. Abbrazzio keeps this information for reference in case you request customer service support.

Abbrazzio may collect certain information when you request technical support for your Abbrazzio products. This information is necessary to identify your systems, configuration and to diagnose your problem to provide a solution. Abbrazzio collects PII from volunteers to complete surveys or participate in polls, to improve Abbrazzio products and services.

Abbrazzio collects PI from customers when they enter promotional programs or to administer to activities, to send promotional e-mails, notify winners, and make winners'list publicly available pursuant.

Abbrazzio collects PII when you ask for newsletters, promotional e-mails, and other information to provide to your request. When contacting us, Abbrazzio may keep PII records of your correspondence, comments, in a file specific to your person.

Sharing your information

Abbrazzio does not sell, trade or rent the PII we collect online. Unless with your permission, Abbrazzio share the PII you provide online only with other Abbrazzio entities and/or business

that provide services to Abbraccio and only for the purposes described above. Where Abbraccio engages third parties to perform services on behalf of Abbraccio, Abbraccio will require them to observe the intent of this Privacy statement.

If Abbraccio is required to provide PII in response to a court order, subpoena, or government investigation, Abbraccio will comply with the request. Abbraccio reserve the right to report to law enforcement agencies any activities Abbraccio believe is reasonably necessary to enforce or apply our Terms and Conditions to protect the rights, property, and safety of others and Abbraccio.

If Abbraccio or its related entities were to merge with or be acquired by another business entity, it is likely that all obligation and rights mentioned in this statement will lie on the then created parties.

Access and change your information

Abbraccio try to ensure you that your information and preferences are accurate and complete. If you have registered your Abbraccio product or created personal profiles online, you may access and change your information by visiting the website where you submitted it.

The use of cookies on the site

Abbraccio sends cookies (a small data file transferred by a website to a persons computer's hard drive) when you surf on the website, respond to online surveys or polls, or request information. Accepting the cookies used on the website does not give Abbraccio access to your PII, but Abbraccio can use the cookies to identify your computer. The collected information permits Abbraccio to analyze traffic patterns on the website to enable Abbraccio to better your experience on the website by improving content and usability.

The use of third-party media

Abbraccio does not run third-party ads on the website. Abbraccio may use third-party media and research companies to place ads for Abbraccio on other parties' websites.

Protecting your information

Abbraccio is committed to protect the information you provide us. To prevent unauthorized access, maintain accuracy, and ensure proper use of information, Abbraccio have employed physical, electronic and managerial processes to safeguard and secure the information Abbraccio collects online.
